SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation: Seek fresh air. Seek medical advice in case of persistent discomfort.

Ingestion: Wash out mouth thoroughly and drink 1-2 glasses of water in small sips. Seek medical advice

in case of persistent discomfort.

Skin: Remove contaminated clothing. Wash the skin thoroughly with water and continue washing for

a long time. Immediately call a POISON CENTER or doctor/physician.

Eyes Open eye wide, remove any contact lenses and flush immediately with water (preferably using

eye wash equipment). Seek medical advice immediately. Continue flushing until medical

attention is obtained.

4.2. Most important symptoms and effects, both acute and delayed

May cause sensitization by skin contact. Symptoms include reddening, swelling, blistering and ulceration – often slowly developing. Eye contact may result in deep caustic burns, pain, tearing and cramping of the eyelids. Risk of serious eye injury and loss of sight. The product contains at least one substance which is a suspected reproductive hazard.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media The product is not directly flammable. Choose extinguishing agents based on the surrounding
